Retainer and Payment

A retainer deposit of \$200.00 of the contracted package is requested at the time the contract is signed, this will reserve the date of your wedding and the services of the photographer. The remaining balance will be due and payable when the contracted time is complete on the day of the wedding. No part of the order will be delivered or uploaded to the Web until the balance is paid in full. The photographer shall refund to the clients the retainer in full in the event of cancellation or postponement of the wedding up to 60 days before the event. The retainer will also be refunded in the event of an act of God, major illness or other casualty which may occur to the client or the photographer. In this case, the photographer shall return the money paid as retainer, to the client but shall have no further liability with respect to this Agreement. This liability (return of the retainer) shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in shipping, or otherwise lost or damaged without fault on the part of the photographer.

Copyright and Reproductions

For valuable consideration, I hereby irrevocably consent to and authorize the use and "respectful" reproduction by Lisa Spradlin, of any and all photographs that she has taken this day of the portrait session or bride and groom's wedding, for any purpose whatsoever, without further compensation to me. All negatives and positives, together with the prints, shall constitute the property of Lisa Spradlin, solely and completely. The terms of this agreement are accepted by the portrait subject or wedding couple.
